

Tourism Authority (Pleasure Craft Licence Fees) Regulations 2007

THE TOURISM AUTHORITY ACT 2006

Regulations made by the Minister under section 129 of the Tourism Authority Act 2006

1. These regulations may be cited as the **Tourism Authority (Pleasure Craft Licence Fees) Regulations 2007**.
2. In these regulations -

"Act" means the Tourism Authority Act 2006;

"licence" means a pleasure craft licence.
3. The fee payable for the first registration of a pleasure craft shall, for the purpose of section 42 of the Act, be as specified in item 1 of the Schedule.
4. The fee payable for the issue of a duplicate registration book shall, for the purpose of section 44 of the Act, be as specified in item 2 of the Schedule.
5. The fee payable for the alteration of the register referred to in section 40 of the Act and to the registration book of the pleasure craft shall, for the purpose of section 50 of the Act, be as specified in item 3 of the Schedule.
6. For the purpose of section 52 of the Act, the fee payable for the registration of a new owner of a pleasure craft shall be as specified in item 4 of the Schedule.
7.
 - (1) A licence issued under section 59 of the Act may be for a private or commercial purpose.
 - (2) The fee payable for the issue of a letter of intent in respect of a licence shall, for the purpose of section 57(6) of the Act, be as specified in item 5 of the Schedule.
 - (3) The fee payable for an application for the issue of a licence under section 57(5)(a) of the Act shall be as specified in item 6 of the Schedule.
 - (4) The fee payable for the renewal of a licence for the purpose of section 57(5)(b) of the Act shall be as specified in item 7 of the Schedule.
 - (5) The fee payable for the issue or renewal of a licence shall, for the purpose of section 57(5) of the

Act, be as specified in item 8 of the Schedule.

8. The fee payable for a duplicate licence shall, for the purpose of section 121 of the Act, be as specified in item 9 of the Schedule.
9. The Tourism (Issue of Pleasure Craft Licences) Regulations 2006 are revoked.
10. These regulations shall come into operation on 1st May, 2007.
