

## 1.0 Application for a Commercial Pleasure Craft Licence

- a) Valid Certificate of Character of applicant OR of the all director(s) of the Company or Societe/Partnership (whichever applicable)/ Receipt of application for certificate of character of applicant/Director(s) along with undertaking form.
- b) Curriculum Vitae applicable for individual applicant only.
- c) Clearance Certificate from Mauritius Revenue Authority (MRA) – Please refer to section 1.1
- d) Builder's certificate specifying name & contact details of builder, Business Registration Number (BRN) and details of craft such as length, beam, type, means of propulsion as well as date of construction of craft among others for new craft/ craft not registered by Tourism Authority.
- e) Business Plan
- f) Registered Sale Deed or proof of ownership (sworn affidavit, if necessary) and accompanied by Registered Declaration Form.
- g) Additional document is required in case craft is imported:
  - MRA customs declaration form
  - Bill of entry
  - Registered declaration form

1. *The Tourism Authority may request any other documents that it deems necessary for processing of the application.*
2. *In case an application is submitted by an Agent/Representative, copy of the National Identity card of the Agent/ Representative and a letter of authorization are also required.*
3. *Applicant to comply with all applicable policies.*

### **1.1 Clearance Certificate from Mauritius Revenue Authority (MRA)**

The applicant can submit their request preferably by e mail at **registration@mra.mu** or in writing to the MRA Office providing for the following information/documents:

- (a) NID/UID/ File No (for companies)
- (b) Name of applicant
- (c) Estimated cost of pleasure craft being purchased
- (d) Applications being made for commercial or private
- (e) Source of funds enabling the acquisition (business income, savings, loan, lease or any other source).

- a) Valid Certificate of Character of applicant OR of the all director(s) of the Company or Societe/Partnership (whichever applicable)/ Receipt of application for certificate of character of applicant/Director(s) along with undertaking form.
- b) Curriculum Vitae applicable for individual applicant only
- c) Quotation for craft. (Specifying Design of craft, Length, Beam, Draught, Price of craft, Number of Pax and Hull Construction (material). If craft is ISO Certified, to submit ISO Certification.
- d) Business Plan
- e) Business Registration Card of builder specifying name, contact details and nature of business with respect building of craft.
- f) In case an application is submitted by an Agent/Representative, the identity card of the Agent/ Representative and a letter of authorization are also required.
